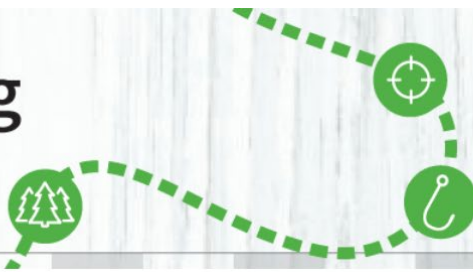

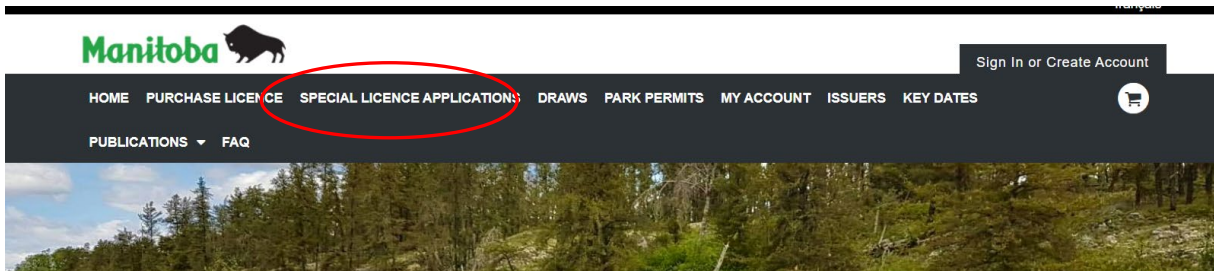


## How to Apply for a Wood Processing Facility Licence

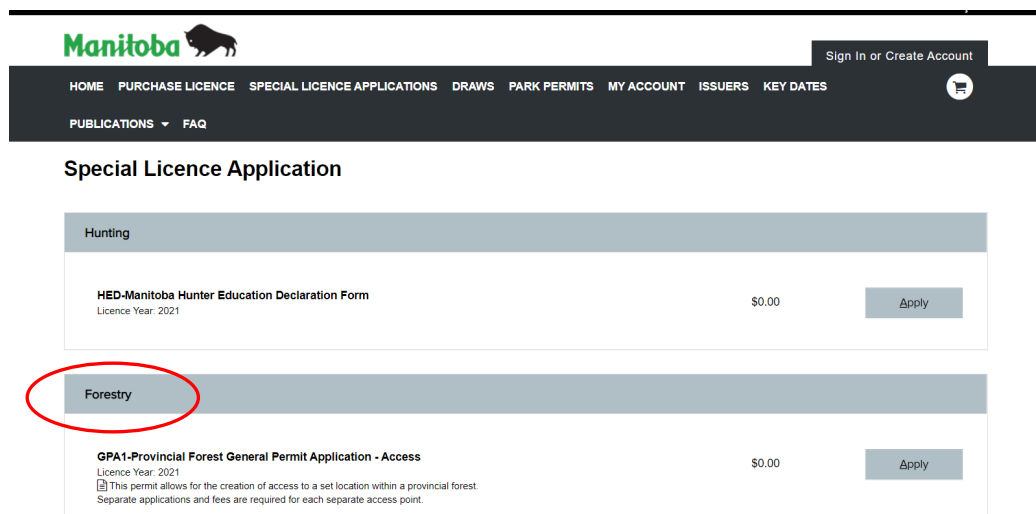
Now that you have created a Manitoba elicensing Customer account, you can purchase items from [Manitoba elicensing](#).

1. To apply for a Wood Processing Facility Licence select “[Special Licence Applications](#)” from the menu options at the top of the screen. In order to successfully complete a transaction through Manitoba elicensing, you are required to have an active Visa or MasterCard. Visa debit is not available as a payment option.

Additionally, you are required to have a printer to print any licences you purchase.



2. Scroll down to the bottom of the list under “Forestry”.

## How to Apply for a Wood Processing Facility Licence

5. The Wood Processing Facility Licence is available for 1, 2, 3, 4 or 5 years. The price is \$30 per year plus the \$4.50 administration fee as displayed below.

Application Description	
A Wood Processing Facility Licence is required by any person who operates a facility that processes timber into a primary or secondary product for sale. It is the licence holders responsibility to renew the licence before the expiration date. The Wood Processing Facility Licence will be issued and the permit fee will be charged after the application is approved. Holders of a Wood Processing Facility Licence are required to keep daily records of all timber processed at the facility.

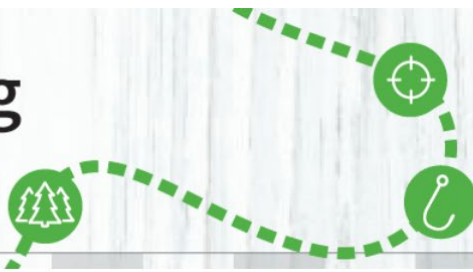
You will need to fill in the following information:

- **Number of Years Applying For:** Select 1 – 5 years
- **Wood Processing Facility Type:** Choose from the available options
- **Location Type:** enter either Latitude and Longitude **or** Section, Township, Range and Meridian (legal land description)
- **Quadrant/Section, Township, Range and Meridian** need to be entered as follows:  
Quadrant four digit alpha numeric - NW24  
Township: two digit numeric - 12  
Range: two digit numeric - 10  
Meridian: is E or W (East or West)
- **Source of Timber:** Select **Private Timber, Crown Timber or Private & Crown Timber**

For Private Timber legal land description needs to be entered as follows:

- **Quadrant/Section, Township, Range and Meridian**  
Quadrant/Section: four digit alpha numeric - NW24  
Township: two digit numeric - 12  
Range: two digit numeric - 10  
Meridian: is E or W (East or West)  
For Crown Timber enter Timber Sale # or Timber Permit # if available (optional)

6. Upload Document and Acknowledgement(s) box section – upload any relevant documents such as a map of the mill location and select the acknowledgment “check box” and select “Submit”.

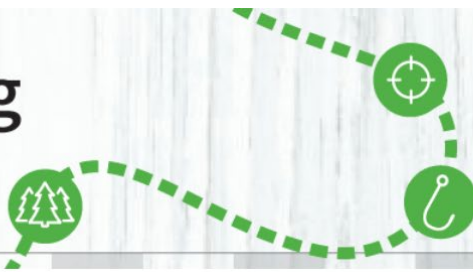
